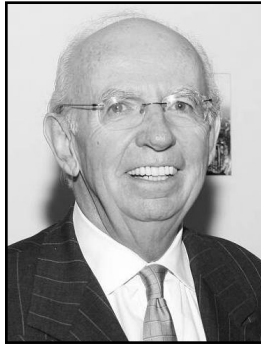

Michael J. Gibbons was raised in the Kingsbridge section of the Bronx. Mike's father hailed from County Mayo in Ireland and his mother was born and raised in Nova Scotia, Canada of Scotch-Irish descent. Mike graduated from St. Francis College in Brooklyn, New York and served in the U.S. Navy.

In 1967, he joined Estée Lauder, Inc., the world's leading manufacturers and marketers of quality cosmetics products. Michael served as Vice President of Clinique and General Manager of Aramis. He retired as an Executive Vice President and General Manager in 2007.

Mr. Gibbons is the former President of The Ireland-U.S. Council, an organization dedicated to promoting business bonds and commercial connections between Ireland and America. During his six years at the helm, the Council's roster of programs and activities has been expanded and its stature has grown on both sides of the Atlantic. The Council operates a variety of scholarship and internship programs, stages seminars and hosts frequent events in Ireland and in the United States.

He is currently a Director of Flax Trust America, a Member of the Mayo Society of New York and a Director of The Irish Institute. He is also a Member of The Taoiseach's Economic Advisory Board in the United States. Mr. Gibbons is a former Chairman of the International Center in New York, a private, not-for-profit organization that welcomes and assists immigrants and refugees to America. He is a past-Director of the American Ireland Fund, the Eugene O'Neill Theater Foundation and the former co-chairman of the Knights of St. Patrick.

Mike and his wife, Cynthia, have four children and four grandchildren. They reside in Palm Beach, FL and Carmel, New York.
